

HIMACHAL PRADESH RAJYA CHAYAN AAYOG, HAMIRPURPRESS NOTE

Himachal Pradesh Rajya Chayan Aayog today declared the result of Written Objective Type Screening Test held on **11.12.2022** for the recruitment of **03** posts {Gen(UR)-03} of **Junior Engineer (Archaeology)** (on contract basis) **Post Code: 1004** as per the award list and ratio approved (1:4) by the Hon'ble Aayog. The requisition to fill up this post was received from **the Director, Language, Art & Culture HP Shimla** and advertised vide advertisement No. **38-2/2022** dated **24.05.2022**.

In response to this advertisement, **1910** applications were received out of which **1414** applications were provisionally admitted.

In the Written Objective Type Screening Test, **585** candidates appeared and **829** candidates remained absent. Out of the total **585** candidates appeared, the following **09** candidates have been provisionally shortlisted for further selection process of document verification:-






